- Luxury motorcoach transportation for all scheduled activities in Orlando per itinerary (including standard driver gratuities)
- Three night accommodations at the Hyatt Place Universal or similar to include full breakfast each morning (located within 20 minutes from all Disney parks and across from Universal)
- Meals Include breakfast each morning at the hotel and meal cards to cover one meal per day at the theme parks
- Admission for three days Disney via one park per day pass
- Admission to Universal Studios via a park to park pass for the full Harry Potter experience
- participation in the "Disney Plays" Workshop
- Arrangements made for renting cellos and string bases at \$45.00 per instrument to include bows
- A US Integrity Touring representative at all times while in Orlando to ensure the smooth operation of your itinerary

*Pricing is based on a minimum of 45 passengers per coach, and on a minimum of 90 participants in the tour. All prices subject to changes in taxes, surcharges, especially fuel surcharges, changes in vendor rates, and submission of the organization's non-profit state tax exempt certificates.

Flower Mound Orchestra Tour to Disney Orlando Payment Schedule:

- A. A first payment of \$300.00 per passenger is due by September 30, 2017.
- B. A second payment of 300.00 per passenger is due October 30, 2017
- C. A third payment of 300.00 per passenger is due by November 30, 2017
- D. A fourth payment of 300.00 per passenger is due by December 30, 2017
- E. A fifth payment of the remaining balance per passenger is due by January 30, 2018

Cost of Tour: The prices quoted are based on tariffs, taxes, and fuel surcharges as of August 9, 2017. In the event of a change in any of these, the right is reserved by USIT to make increases in prices to the Participant or a substitution of services. Also, USIT reserves the right to withdraw any portion or all of any travel package to make such alterations or substitutions as it deems necessary or desirable to maintain the safety, value and integrity of the tour. Should an element of the program become unavailable through accident, act of God, or other circumstance beyond USIT's control, USIT will make substitutions that are superior or as close to equivalent as possible. Should any interruption in services occur due to an act of God or circumstances beyond the control of the Agent, such as a missed flight due to inclement weather, the Agent will help the Client find the best solution to the difficulty, but any additional cost due to such a difficulty shall be the responsibility of the Client and/or its individual participants. **The price charged is based on the participation level by room occupancy (single, double, triple, or quad) as stated on this form, and this constitutes the "applicable fare".**

Cancellation Policy: Cancellations and requests for refunds must be submitted in writing to your organization. All documents, including tickets of any value, must be returned to USIT before any refund can be processed. Cancellation charges, per person, are **figured against the full price** and may be as much as shown here:

1. From signup until 90 days before departure (January 4, 2018) = 25% of full price (\$356.41)
2. 60-90 days before departure (February 4, 2018) = 50% of full price (\$712.82)
3. 40-60 days before departure (February 24, 2018) = 75% of full price (\$1,069.23)
4. 0-40 days before departure or later = 100% of the full price (no refund)

Participants paying late may be subject to a late fee of 2.5% for the amount overdue for each month or part thereof. No refunds will be given until after the original dates of travel. (If the full tour is canceled because of district disapproval due to unsafe travel conditions or due to the Agent deciding that prevailing conditions are not safe enough to conduct the tour, the cancellation charge will be reduced to 12% of the total fare for all passengers as long as written cancellation is received by the Agency from the approving authority at least 65 days prior to departure (January 30, 2018), plus the cost of items such as event tickets, airline deposits, vendor penalties, hotel deposits, or any other payments made on your behalf that become non-refundable prior to the January 30, 2018 cancellation date. The cost of these items will be added to the 12% charge

assessed. (Should the tour not be canceled under the provisions of this paragraph, then the normal cancellation charges will apply, regardless of the reason for cancellation.)

Responsibility: USIT acts only as an agent in providing means of transportation, hotel, or other services. Since USIT contracts only with reputable vendors and service-providers (such as hotels, airlines, coach companies, etc.), each is responsible for the goods and services they provide. The participant is subject to any and all terms and conditions under which such goods and services are provided by the vendors, and registration for this tour constitutes agreement by the participant/legal guardian that USIT shall not be, nor become liable or responsible in any way for any loss, injury, or damage to or in respect of any person or property, including baggage, caused or arising in connection with such means of transportation or other any services provided in the fulfillment of this tour. USIT also reserves the right to decline, accept, or retain any participant as a member of this tour and shall not have responsibility to declined individuals beyond the refund of an appropriate portion of monies paid by the participant to USIT. It is the responsibility of each participant to behave in a responsible and safe manner. USIT in its sole discretion reserves the right to send home any participant at the Participant's expense, including the cost of an escort, who is disruptive of the tour or engages in any illegal activity.

Notice: Passengers are limited to one suitcase (the sum of height, width, and depth not to exceed 58 inches), and an instrument or carryon of 25 lbs. (the sum of height, width, and depth not to exceed 35 inches).

Participant/Guardian affirmation:

I have been informed that trip cancellation insurance is not included in our package. Many companies offer trip cancellation insurance such as Travel Guard, Travel X or AAA and you must enroll directly with the insurance company. I understand that if I wish to have pre-existing medical conditions waived, I must purchase the insurance within fourteen days of making my initial trip deposit and meet other insurance company conditions.
